“**authorisations**” means all licenses, permits, or approvals of whatsoever nature required by you in terms of any regulatory provision to enable you to exercise your rights and fulfill your obligations under these Terms of Use.

Should any of the terms of these Terms of Use conflict with any of the terms contained in any other written agreement you may have concluded, by means of handwritten signatures (or digital signatures created using a LAWtrust issued digital certificate (see [www.lawtrust.co.za](http://www.lawtrust.co.za))), with e4, then those terms, to the extent where there is a conflict, contained in the signed agreement shall prevail. **NO TERMS AND CONDITIONS CONTAINED ON YOUR PURCHASE ORDER, ORDER ACCEPTANCE FORMS AND/OR INVOICES SHALL APPLY TO, SUPPLEMENT OR SUPERSEDE ANY TERMS AND CONDITIONS OF THESE TERMS OF USE.**

3. **PIN CODE & DIGITAL ID:**

You are and remain responsible for ensuring that you maintain the confidentiality and/or protection from compromise (e.g. lost, stolen, used wrongfully, or used by any other person) of any personal identification number (PIN) and/or digital identity (e.g. digital certificate) that may be issued to you and used, amongst other things, to identify you to the e4 website, web service or mobile app, and you shall be fully responsible for all activities that occur when the PIN code or digital identity, as the case may be, is used, with or without your knowledge.

We will endeavour to investigate your claim and formally respond in writing within 21 days from that date of receipt by us of your initial request therefor. Should you qualify for refund, such will be processed within a reasonable period thereafter.
